Introduction

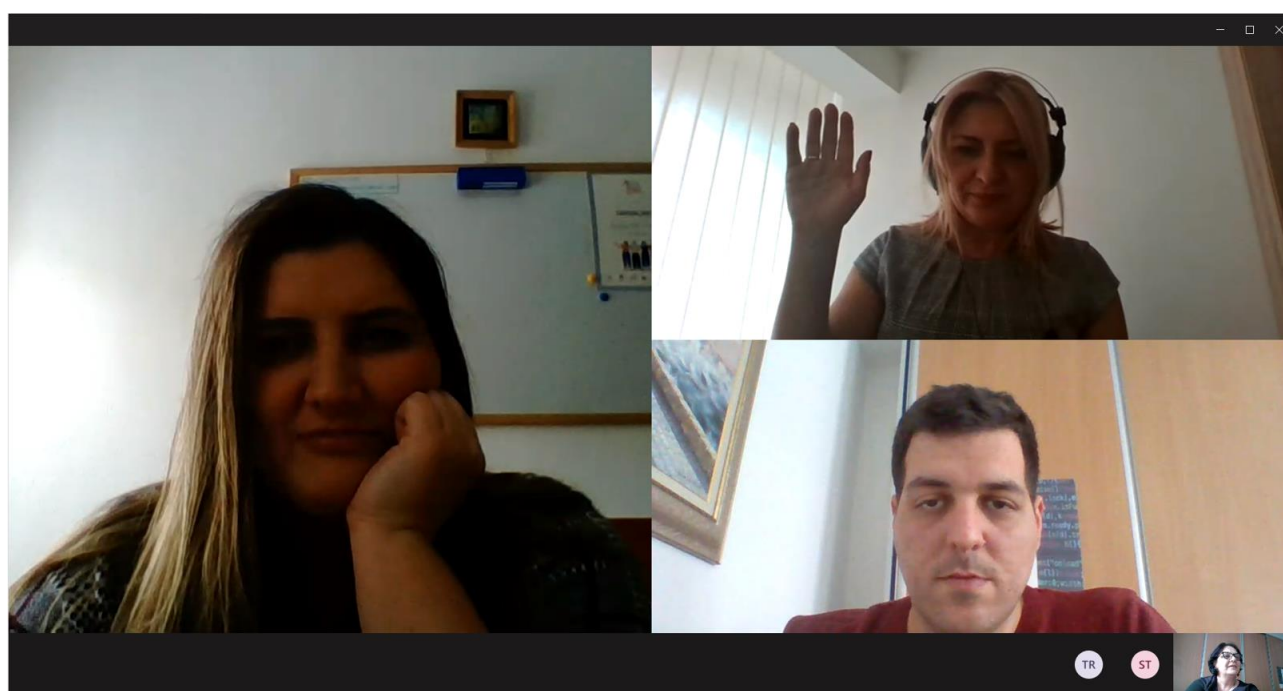

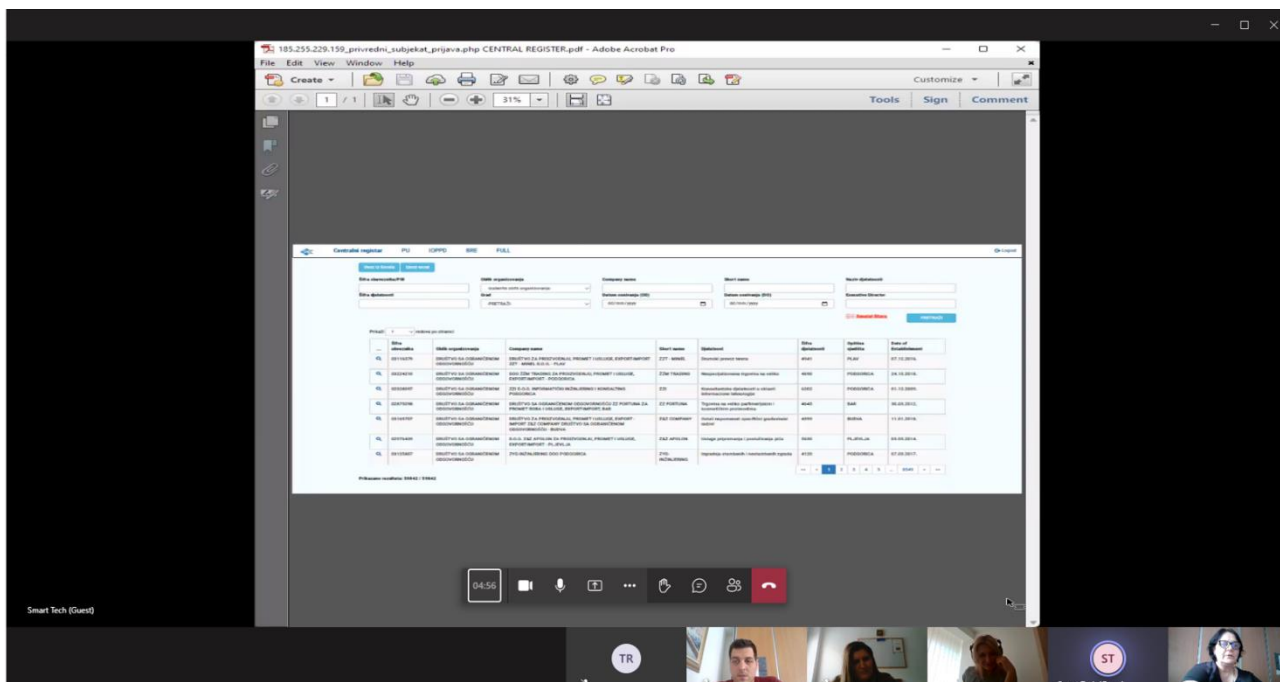
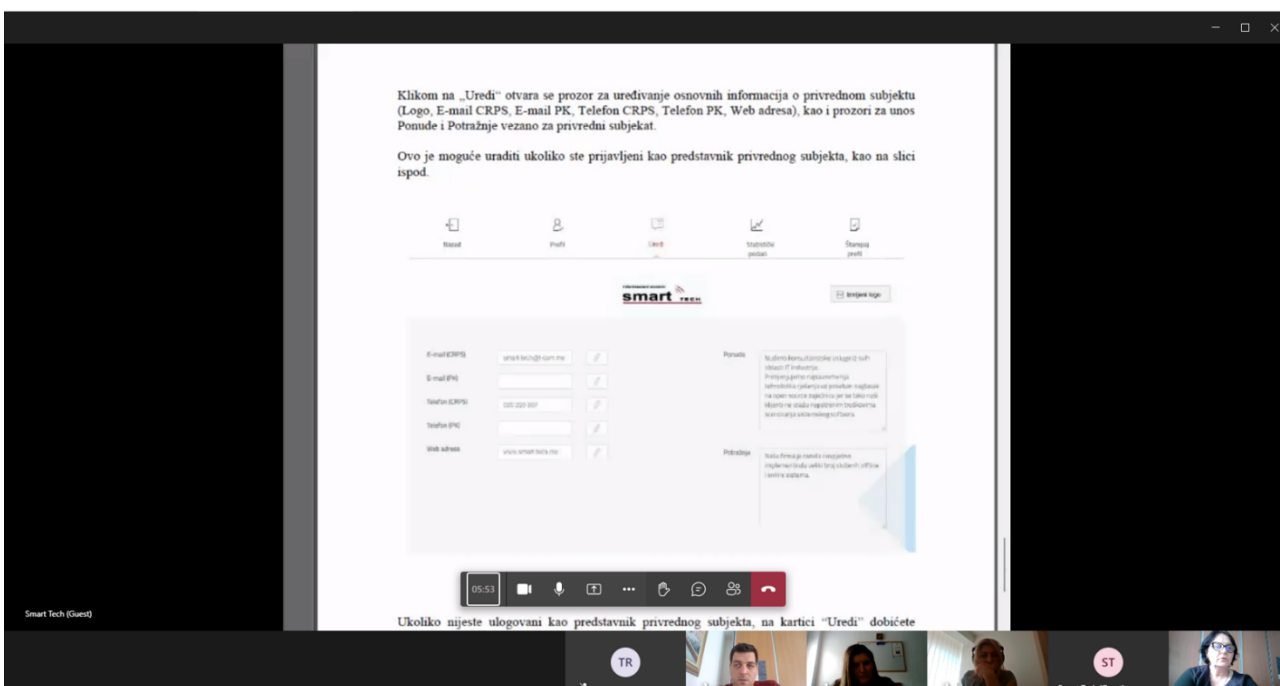
Training Content
